



All bidders must register with both the Pueblo County Treasurer and the auction provider SRI in order to participate in the Tax Lien Sale. Once a bidder has registered with both parties, the Pueblo County Treasurer will inform SRI that the bidder is approved to start bidding. This can take up to 24 hours. Registration will take place from October 1, 2010 through October 8, 2010 at 4:30 p.m. No registration will be allowed after October 8, 2010.

Registration with Pueblo County involves fully completing a Registration Form and a W-9 Form. These forms are available on www.co.pueblo.co.us/treasurer. The completed forms together with a voided check for the account to be charged for all winning bids must be mailed or faxed to the Pueblo County Treasurer as instructed on the registration form. It is the bidder's responsibility to insure that the information supplied on all registration forms is legible and correct and that the name(s) supplied on these forms is the same since the Certificates of Purchase are prepared from this information. Each bidder will bid and purchase in the name(s) listed on the registration form. Bidders must register with the same name(s) when registering with Pueblo County Treasurer and SRI.

Payment for all winning bids will be made by automatic withdrawal from the bidder's United States checking or savings account to Pueblo County at the conclusion of the auction. This is the only form of payment accepted. Payment transfers that are rejected due to lack of funds or other reasons may result in cancellation of the corresponding bid(s) subject to CRS 39-11-116.
