

**RESOLUTION NO. 18- 304**

**THE BOARD OF COUNTY COMMISSIONERS  
OF PUEBLO COUNTY, COLORADO**

**APPROVING THE 2019 GRANT CONTRACT BETWEEN THE VICTIM ASSISTANCE AND  
LAW ENFORCEMENT (V.A.L.E.) BOARD, IN AND FOR THE TENTH JUDICIAL DISTRICT,  
AND PUEBLO COUNTY**

**WHEREAS**, authority exists, pursuant to C.R.S. § 24-4.2-105, for a Victim Assistance and Law Enforcement (V.A.L.E.) fund to award grants for victim assistance services; and

**WHEREAS**, this Board authorized the District Attorney of the Tenth Judicial District to make application for 2019 funding from the Victims and Witnesses Assistance and Law Enforcement Fund by Resolution No. 18-255, dated October 9, 2018 on behalf of the Victim Services units of the District Attorney's Office; and

**WHEREAS**, the V.A.L.E. Board of the 10<sup>th</sup> Judicial District approved said application and desires to award \$64,782.00 for the grant period of January 1, 2019 to December 31, 2019, contingent upon the availability of Victim Assistance and Law Enforcement Funds and approval of the Statement of Grant Award (SOGA) and execution of the Grant Contract submitted by the V.A.L.E. Board; and

**WHEREAS**, the SOGA and Grant Contract between the 10th Judicial District V.A.L.E. Board, in and for the Tenth Judicial District and Pueblo County, c/o the Pueblo County District Attorney's Office as Grantee, does not require matching funds by Pueblo County and this Board desires to accept the grant funds as stated above and approve the SOGA and execute the Grant Contract.

**WHEREAS**, the officers, employees and agents of the County are hereby authorized and directed to take all action necessary or appropriate to effectuate the provisions of this Resolution.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Pueblo County, Colorado, that the 2019 SOGA and Grant Contract are approved and the 2019 grant award of \$64,782.00 from V.A.L.E. is hereby accepted; the Grant Contract between V.A.L.E. and Pueblo County, the terms and conditions of which are incorporated herein by this reference, is hereby approved, and the Chair of the Board of County Commissioners of Pueblo County, Colorado, is authorized to execute said Grant Contract on behalf of Pueblo County.
