

RESOLUTION NO. 17-081

**THE BOARD OF COUNTY COMMISSIONERS
OF PUEBLO COUNTY, COLORADO**

**APPROVING THE INTERGOVERNMENTAL AGREEMENT FOR COOPERATIVE
WILDFIRE PROTECTION BETWEEN PUEBLO COUNTY, THE PUEBLO COUNTY
SHERIFF'S OFFICE AND THE STATE OF COLORADO, DEPARTMENT OF
NATURAL RESOURCES, DIVISION OF PARKS AND WILDLIFE AND THE
DEPARTMENT OF PUBLIC SAFETY, DIVISION OF FIRE PREVENTION AND
CONTROL**

WHEREAS, in accordance with C.R.S. § 24-33.5-1221 the County and any state agency that owns wildland areas within the county are required to enter into an intergovernmental agreement to mitigate the harm caused by wildland fire affecting land areas in the interest of protecting public health and safety; and

WHEREAS, the Colorado Division of Natural Resources, Colorado Division of Parks and Wildlife ("CPW") owns wildland areas within Pueblo County; and

WHEREAS, in order to comply with C.R.S. §24-33.5-1221 and to facilitate the coordination and exchange of personnel, equipment, supplies, services, and funds in sustaining and implementing wildland fire management activities, the Pueblo County Sheriff's Office Emergency Services Bureau desires to enter into an Agreement for Cooperative Wildfire Protection between Pueblo County and the Pueblo County Sheriff's Office Emergency Services Bureau, the Colorado Division of Natural Resources, Division of Parks and Wildlife and the Colorado Department of Public Safety, Division of Fire Prevention and Control; and

WHEREAS, CPW shall, in accordance with the provisions of the Intergovernmental Agreement, provide reimbursement to Pueblo County for certain costs the County and/or Sheriff incurs during the suppression of a Wildland Fire on CPW Land; and


WHEREAS, this Board desires to enter into an Intergovernmental Agreement for Cooperative Wildfire Protection between Pueblo County, the Pueblo County Sheriff's Office, the State of Colorado, Department of Natural Resources, Division of Parks and Wildlife and the Colorado Department of Public Safety, Division of Fire Protection and Control.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Pueblo County, Colorado, that the Intergovernmental Agreement between Pueblo County, on behalf the Pueblo County Sheriff's Office, for Cooperative Wildfire Protection between Pueblo County, the Pueblo County Sheriff's Office, the State of Colorado, Department of Natural Resources, Division of Parks and Wildlife, and the Colorado Department of Public Safety, Division of Fire Protection and Control, the terms and conditions of which are incorporated herein by this reference, is hereby approved, and the Chairman of the Board of County Commissioners of Pueblo County, Colorado, and the Pueblo County Sheriff are hereby authorized to execute said Intergovernmental Agreement on behalf of Pueblo County.
