

**VERBATIM TRANSCRIPT SOUTHERN DELIVERY SYSTEM
HOUSE BILL 1041 PERMIT
PUEBLO BOARD OF COUNTY COMMISSIONERS' HEARING
FEBRUARY 25, 2009**

JEFF CHOSTNER: The meeting will come to order. The Board of County Commissioners which had recessed a couple of weeks ago is now back in session. The time is 6:00 p.m. on Wednesday, the 25th of February, 2009. In attendance are Commissioner Cordova and Mr. Chostner. Commissioner Nuñez is excused for other business. Also in attendance are County Attorney Dan Kogovsek and Special Attorney Gary Raso. Sue Kovacich is here as well as Clerk to the Recorder. At this time, Mr. Raso, I would the meeting over to you.

GARY RASO: Thank you, Commissioners. This is a continuation from February 11, 2009 on House Bill 1041 Permit 2008-002. At the meeting on the 11th, this matter was continued to this evening and staff is recommending to the Board that this matter be continued once again until March 18, 2009. This will allow us to continue work on essentially what might be, what we as staff would want the Commissioners to consider as possible terms and conditions on this House Bill 1041 permit. We're simply not ready yet to submit, fully submit, that to the Commissioners and we would like the additional length of time. The applicant is aware of this request, as you can see they're not here. They are in agreement with the request for the continuance.

JEFF CHOSTNER: It would be until 6:00 p.m.

GARY RASO: Yes, it would be at 6:00 p.m., March 18, 2009, here in Chambers at the County Courthouse.

JEFF CHOSTNER: Mr. Cordova, any comments?

JOHN CORDOVA: No, I would so move.

GARY RASO: Commissioner Chostner.

JEFF CHOSTNER: Second. The only comment I would make is this would be the third time, I think, that we could continue this. And, I think, it's the opinion of all the Commissioners that we put the effort to this because come next week we expect one way or another to be issuing conditions, if that's the way we go, if we decide to do that. I think we want to make sure we have some resolution of this by this time next week. So with that I would ask that all Commissioners in favor of the motion to say "aye".

JOHN CORDOVA: Aye.

JEFF CHOSTNER. Aye. Motion passes. We are continued until 6:00 p.m., March 18, 2009, here in the Pueblo County Courthouse Chambers.

GARY RASO: Thank you.

JEFF CHOSTNER: Is there anything else to become before us?


