On behalf of the SDS Project Participants and pursuant to the Pueblo County 1041 Permit No. 2008-002, Mitigation Appendix Condition C-7, No. 2 - Permitting, we have enclosed copies of permits obtained by our General Contractor for the SDS Project. These include Colorado Department of Public Health and Environment (CDPHE) permits for Construction Dewatering Operations, Stormwater Discharges Associated with Construction Activities, and the transfer of Colorado Springs Utilities Land Development General Permit for air emissions to ASI Constructors, Inc.

Subject: Safety Review of Design and Proposed Construction of Pueblo Dam Connections

Work Package 1A, Southern Delivery System - Fryingpan Arkansas Project, Colorado

Dear Mr. Duling:

Reclamation understands that Colorado Springs Utilities plans to construct Pueblo Dam Connections Work Package 1A in 2011. Construction activities for this work package will include: a connection to the existing outlet regulating gate of the River Outlet Works at Buttress 16 of Pueblo Dam; a new stainless steel liner within Pueblo Dam; a fixed cone valve facility at the toe of Pueblo Dam with a mass concrete foundation within the Arkansas River; a 60-inch fixed cone valve for river discharges; and a 90-inch welded carbon steel pipe extending from the fixed cone valve facility to the north bank of the Arkansas River. The Colorado Springs Utilities has submitted design drawings and specifications for this project (design construction plans) to Reclamation for review.

Actual construction cannot start until the Long-term Excess Capacity and Conveyance contract between Colorado Springs Utilities and Reclamation has been executed.

Reclamation has reviewed the design construction plans and completed a dam safety review of the planned construction. This letter documents acceptance by Reclamation of the submitted design construction plans.
