The Annual Fee for this certification is \$245.00, and is invoiced every July. **Do Not Pay This Now**. The initial prorated invoice will be sent to the legal contact shortly.

The Division is currently developing a new permit and associated certification for the above permitted facility. The development and review procedures required by law have not yet been completed. The Construction Stormwater General Permit, which will expire June 30, 2012, will be administratively continued and will remain in effect under Section 104(7) of the Administrative Procedures Act, C.R.S. 1973, 24-4-101, et seq (1982 repl. vol. 10) until a new permit/certification is issued and effective. The renewal for this facility will be based on the application that was received 8/30/2012.
