Colorado Springs Utilities (CSU), the Southern Delivery System (SDS) Project Manager, submitted the Permit Compliance Annual Report (PCAR) for Calendar Year 2012. The intent of this report was "...to demonstrate... SDS Project progress to successfully implement the commitments as prescribed in the SDS ROD [Record of Decision], Reference No.: GP-2009-01....." Page 11 of the SDS Record of Decision (ROD) provides that "Comprehensive monitoring of the implementation of the Participants' environmental commitments for the SDS Project will be coordinated between the Bureau of Reclamation, the Project Participants, and the authorities responsible for these additional separate permits, approvals, and agreements."
